- * Bookings and Payments need to be made prior to attending classes or workshops at RYS.
- * Space is only guaranteed in this setting when pre-booked and prepaid.

**Workshops at
various venues**

- * Bookings and Payments need to be made prior to attending.
- * A full refund is applicable if the workshop is under-subscribed or cancelled.
- * No refunds are given for cancellations within 48 hours of the start date or no shows.

Online classes

- * Online classes need to be booked before the start time, otherwise the class may be cancelled.
- * Online classes are taught on the proviso that participants have adequate equipment at home and some prior experience in yoga.
- * Class passes for online classes have no expiry date.

**Private Tuition
Classes / Blocks
Updated 2026**

- * Payment for class(es) / blocks are to be made prior to sessions.
- * Cancellation of one (1) of the '5 block' sessions 24 hours before may be rescheduled ONCE at no cost.
- * Cancellations of "5 block" sessions within 24 hours are non-refundable / non-rescheduleable.
- * Once dates are booked, the '5 dates' blocks are non-refundable and non-transferable.
- * Students engaging for 12 months ongoing sessions are required to give notice of away dates for mutual planning purposes.
- * Any cancellations of private sessions from my end are credited in full and can be mutually rescheduled or the cost for the session carried forward.

**BALI Retreats
2026 - 27
Updated 2026**

- * A deposit sum is quoted per person upon registration and is required to hold a place & block requested room accommodation at the Bali retreat venue.
- * Travel Insurance must have: Upon booking all participants must present proof of relevant comprehensive travel insurance for the retreat dates to attend the Bali retreat. It is up to the Bali retreat participants to check insurance requirements and the conditions of entry into Bali when planning their trip.
- * Full fees are to be paid by the due date stated, 3 months out from the start date.
- * Fees quoted DO NOT include airfares, visas or travel insurance.
- * Deposits are only 50% refundable up until 8 weeks before the start date. Deposits are non-refundable within 8 weeks of the start date.
- * Participants must follow the official entry and exit conditions for travel from your Australian State or any other country to Bali if applicable. No refund for the Bali retreats will apply if entry is denied upon arrival or en-route travel is restricted by airlines, Australian, Overseas or Indonesian government entry requirements or any remissions in exit or entry requirements that occur with the participant's travel arrangements that prevent the participant attending the retreat in part or full.
- * A refund of 50% of any full fees paid may apply if a participant has to cancel up to 4 weeks before the start date due to extraneous circumstances OR a credit for future retreats may be considered. No refund will be applicable for cancellations of any nature or no shows within 4 weeks of the retreat start date.
- * If the Bali Retreat is not adequately subscribed the retreat may be cancelled. In this event, the participants will be notified and a full refund will be arranged.
- * In the event of extraordinary circumstances ie: natural disaster or government directed lockdowns or any other government restriction that prevents the Bali retreat from going ahead, a full refund minus the original deposit may apply.
- * **Bali Retreat Disclaimer:** A safe and caring environment is provided for all participants and the Bali retreat program is carefully planned, however no responsibility will be taken for any injuries incurred during the retreat. Notification of any medical history is requested via email before the start of the retreat (via the contact form provided). It is also advisable to consult your doctor if you have any pre-existing medical conditions. Modifications are given if appropriate.

- * A deposit sum, quoted per person, is required upon registration to hold a place & block requested room accommodation at the retreat venue.
- * Full fees are to be paid by the due date stated, usually 1 month out from the start date.
- * Fees quoted DO NOT include travel costs.
- * Deposits are only 50% refundable up until 4 weeks before the start date. Deposits are non-refundable within 4 weeks of the start date.
- * A refund of 50% of any full fees paid may apply if a participant cancels 2 weeks before the start date due to extraneous circumstances OR a credit for future retreats may be considered. No refund will be applicable for cancellations for any reasons within 2 weeks of the start date or no shows.
- * If the Retreat is not adequately subscribed the retreat may be cancelled. In this event, the participants will be notified and a full refund will be arranged.
- * In the event of extraordinary circumstances ie: natural disaster or government directed lockdowns or any other government restriction that prevents the retreat from going ahead, a full refund will apply.
